Terms Of Service

Please read these Terms and Conditions ("Terms", "Terms and Conditions") carefully before using the www.voluntaryrefundvalue.com website and the VRV mobile application (together, or individually, the "Service") operated by VRV LLC ("us", "we", or "our").

Your access to and use of the Service is conditioned upon your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who wish to access or use the Service.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you do not have permission to access the Service.

Purchases

If you wish to purchase any product or service made available through the Service ("Purchase"), you may be asked to supply certain information relevant to your Purchase including, without limitation, your credit card number, the expiration date of your credit card, your billing address, and your shipping information.

Subscriptions

At the end of each Billing Cycle, your Subscription will automatically renew under the exact same conditions unless you cancel it, or VRV LLC cancels it. You may cancel your Subscription renewal either through your online account management page or by contacting VRV LLC customer support team.

A valid payment method, including credit card or PayPal, is required to process the payment for your Subscription. You shall provide VRV LLC with accurate and complete billing information including full name, address, state, zip code, telephone number, and a valid payment method information. By submitting such payment information, you automatically authorize VRV LLC to charge all subscription fees incurred through your account to any such payment instruments.

Should automatic billing fail to occur for any reason, VRV LLC will issue an electronic invoice indicating that you must proceed manually, within a certain deadline date, with the full payment corresponding to the billing period as indicated on the invoice.

Fee Changes

VRV LLC, in its sole discretion and at any time, may modify the Subscription fees for the Subscriptions. Any Subscription fee change will become effective at the end of the then-current Billing Cycle.

VRV LLC will provide you with a reasonable prior notice of any change in Subscription fees to give you an opportunity to terminate your Subscription before such change becomes effective.

Your continued use of the Service after the Subscription fee change comes into effect constitutes your agreement to pay the modified Subscription fee amount.

Refunds

Except when required by law, paid Subscription fees are non-refundable.

Recycling Schedule & Rules

Recycling begins every Friday at 17:00:01 and ends next Friday at 16:59:59. To recycle your materials, you must be within 0.02 miles from a recycling facility for the material you want to recycle. Furthermore, spoofing your GPS will disqualify you from contests, sweepstakes or other promotions made available through the Service.

Completed Vrv deposit

According to the recycling schedule, a completed Vrv deposit is when a user recycles (turns in) their material(s) at a recycling facility on time (Every Friday before 5:00 pm PST).

Contributions

Users can contribute. Contributing is in the current funds screen.

All Sales Final

Google Pay and Apple Pay uses encryption and requires biometric authorization before you can submit a Vrv deposit or Vrv contribution. Accordingly, all sales (Vrv deposits and Vrv contributions) are final. Therefore, users will be responsible for a chargeback fee if they report their \$1.00+ Vrv deposit or \$1.00+ Vrv contributions as unauthorized to their bank.

Accounts

When you create an account with us, you guarantee that you are above the age of 18, and that the information you provide us is accurate, complete, and current at all times. Inaccurate, incomplete, or obsolete information may result in the immediate termination of your account on the Service.

You are responsible for maintaining the confidentiality of your account and password, including but not limited to the restriction of access to your computer and/or account. You agree to accept responsibility for any and all activities or actions that occur under your account and/or password, whether your password is with our Service or a third-party service. You must notify us immediately upon becoming aware of any breach of security or unauthorized use of your account.
