VRV RECYCLING CONTEST RULES

1. **The Contest:** Voluntary Refund Value conducts two recycling themed game based contests in the form of a daily word game contest (the “Daily Contest”) and weekly chess game Sunday contest (the “Sunday Contest”) (collectively referred to as the “Contest”).
2. **Contest Period:**
 - a. Week #3 (4.6.20 – 4.12.20) the Daily Contest begins every day (Monday-Sunday) at 8:00:00 AM PST and ends at 5:00:00 PM PST (the "Daily Contest Period").
 - b. The Sunday Contest is open to Entrants (as defined below) who complete their recycling between 5:00:01 PM PST on the Friday of previous week and by or before 4:59:59 PM PST on the Friday immediately before the applicable Sunday Contest (the “Sunday Contest Period”). For example, the Sunday Contest Period for Sunday of the week of January 6-12, 2020, you must complete your recycling between 5:00:01 PM PST Friday January 3 and 4:59:59 PM PST January 10 to be eligible to compete in the Sunday Contest on January 12. The Sunday Contest will be held between 3:00:00 PM PST to 3:10:00 PM PST on Sunday.
3. **Sponsor:** All Promotions are sponsored by VRV, LLC, located at 1624 Telegraph Ave, 2nd Floor Oakland, CA 94612 (“Sponsor” or “VRV”).
4. **Agreement to Rules and Eligibility:**
 - a. By participating, entrants (individually an “Entrant” and collectively “Entrants”) agree to be fully unconditionally bound by these Rules and represent and warrant that they meet the eligibility requirements set forth herein. In addition, Entrants agree to accept the decisions of Sponsor as final and binding as it relates to the Contest. The Contest is subject to all applicable federal, state, and local laws. Sponsor in its sole discretion, reserves the right to disqualify any Entrant it finds to be tampering with the VRV App (as defined below) or is otherwise in violation of these rules.
 - b. The Contest is open to legal residents of the U.S. who are eighteen (18) years of age or older at the time of entry. The Contest is subject to all applicable federal, state, and local laws. Void where prohibited. Entrants based in **Colorado, Connecticut, Maryland, Nebraska, Arizona,** and **North Dakota** are **ineligible for the Contest**.
 - c. Employees, agents, agent staff, officers, and directors (including immediate family members) of Sponsor, including its affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, contractors, printers, web design, and advertising and promotion agencies, and any and all other companies or individuals associated with the administration, development, fulfillment and execution of this Contest (collectively, "Promotion Parties") are not eligible to participate. The term "immediate family member" includes spouses, grandparents, parents, siblings, children, and grandchildren and "step" of each. In addition, those living in the same households (those persons whether related or not who live in the same residence for at least three (3) months during the twelve-month period preceding the start date of the Contest) are not eligible to participate in this Contest.

- d. Entrants are eligible to win the Daily Contest only once per day and only eligible to win the Sunday Contest once per the week. Teamwork is permissible for the Daily Contest and the Sunday Contest.
- e. All entries become the sole property of Sponsor and will not be returned.

5. How to Enter:

- a. To enter the Daily Contest: (i) Download the Voluntary Refund Value app (the “VRV App”), (ii) set up your recycling schedule for \$1.00 (the “Scheduling Fee”), and (iii) play the Daily Contest word game (the “Word Game”) and compete to be the quickest to complete the Word Game. Scheduling Fees are non-refundable. Scheduling Fees will only be refunded if the total schedules for the day are less than or equal to \$99 during (the "Daily Contest Period") set forth in section 6a1.
- b. To enter the Sunday Contest: (i) Download the Voluntary Refund Value app (the “VRV App”), (ii) set up your recycling schedule and pay the Scheduling Fee, AND (iii) complete your recycling during the applicable Sunday Contest Period. For example, if you want to compete in the Sunday Contest for the week of January 6-12, 2020, complete your recycling between 5:00:01 PM PST Friday January 3 and 4:59:59 PM PST January 10 and you will be eligible to compete in the Sunday Contest on January 12. Entrants who meet these requirements will then be eligible to play the Sunday Contest chess game (the “Chess Game”) and compete to be the quickest to complete the Chess Game. Scheduling Fees are non-refundable. Scheduling Fees will only be refunded if the total schedules for the day are less than or equal to \$99 during (the "Daily Contest Period") set forth in section 6a1.
- c. Sponsor recommends use of a wireless connection while completing Word and Chess Games as LAN connections may cause an Entrant’s participation to register while preventing completion of the applicable game.

6. Prizes:

- a. Contest Winners (as defined below) of the applicable Daily Contest will win prizes set forth in section 6a1 during the applicable Daily Contest Period (the “Daily Contest Prize”). For Monday, the Daily Contest Prize will be Vrv’s iPhone 6s, one \$25.00 Starbucks gift card and eight \$10.00 Starbucks gift cards.

The Daily Contest Prize for Tuesday-Sunday are based on Scheduling fees. For example, if Scheduling Fees are between \$900 - \$999, the Daily Contest Prize will be fifteen \$20.00 Starbucks gift cards. Another example, if Scheduling Fees are between \$5,000 - \$5,999, the Daily Contest Prize will be an iPhone, one \$100 and thirteen \$20.00 Starbucks gift cards.

- b. Contest Winners (as defined below) of the applicable Sunday Contest will win prizes set forth in section 6a1, during each of the previous seven (7) Daily Contest Period (the “Sunday Contest Prize”). Sunday Contest Prize will be \$10.00.
- c. The Daily Contest Prize and the Sunday Contest Prize are collectively referred to as the “Prize.”

- d. Subject to this Section 6, contest winners of the Daily Contest will receive the Prize (If cash) via Google Pay or Apple Pay on or before 11:30:00 PM PST the date of entry. Contest winners of the Daily Contest will receive the Prize (If gift card) on or before 11:30:00 PM PST the date of entry. Contest Winners of the Daily Contest will receive the Prize (If iPhone) tracking number on or before 11:59:59 PM PST the date of entry. Contest Winners of the Daily Contest will receive the Prize (\$1300 cash equivalent) via Google Pay or Apple Pay if the iPhone is unavailable (out of stock) on or before 11:59:59 PM PST the date of entry.
- e. Prizes are non-transferable. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winners is permitted.
- f. If the Contest Winner (as defined below) is unwilling or unable to accept the Prize requirements, such Contest Winners shall be disqualified and all privileges otherwise due as a Contest Winner shall be terminated and an alternative Contest Winner may be chosen from among all of the remaining eligible entries received if time permits in Sponsor's sole discretion (as further detailed in Section 7(b) below). Contest Winners must complete a prize affidavit form before they will receive the Prize.

7. Winner Selection and Notification:

- a. **Selection.** The Sponsor will select a winner of the Daily Contest based on the Entrant who completes the Word Game in the least amount of time during each Daily Contest Period and the winner of the Sunday Contest based on the Entrant who completes the Chess Game in the least amount of time during each Sunday Contest (with winning Entrants each a "Contest Winner"). In the event that multiple Entrants complete the applicable Word Game or Chess Game in the same amount of time, those Entrants will complete an additional Word Game or Chess Game and the Entrant to complete the additional puzzle in the least amount of time will become the Contest Winner. To ensure accuracy for the Word Game, sponsor calculates potential Contest Winners based on Sponsor's API response time records associated with each Entrants' completed game in Milliseconds. For the Chess Game, the fastest timestamp submission is used. Set forth in section 6, for Monday there will be [10] Contest Winners. 1st place wins Vrv's iPhone 6s, 2nd place wins a \$25 Starbucks gift card, 3rd-8th place wins a \$10.00 Starbucks gift card. Winners for Tuesday-Sunday are based on Scheduling fees. For example, if Scheduling Fees are between \$5,000 - \$5,999, there will be [15] Contest Winners of each Daily Contest. 1st place wins the iPhone (or \$1300 cash equivalent), 2nd place wins \$100 and 3rd-15th place wins a \$20.00 Starbucks gift card. For Sunday there will be [1] Contest Winner(s) of each Sunday Contest.
- b. **Notification.** Sponsor or its designated representative will make a minimum of three (3) attempts to contact the eligible Contest Winner by way of either push notification sent through the VRV App, email, text message, or phone call, before 11:30:00 PM PST on the day the eligible Contest Winner is identified as a potential Contest Winner (the "Identification Date"). If an eligible Contest Winner cannot be contacted by or before the relevant Identification Date, or if there is a return of any notification as undeliverable; then he/she may, in the sole and absolute discretion of the Sponsor, be disqualified (and, if disqualified, will forfeit all rights to be a Contest Winner) and the

Sponsor reserves the right, in its sole and absolute discretion and time permitting, to select an alternate eligible Contest Winner by selecting the Entrant who completed the applicable Word Game of Chess Game in the next least amount of time.

8. Terms:

- a. Sponsor reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Contest should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness, or proper conduct of the Contest. In such a case, Sponsor may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest, VRV App, or violates these Contest Rules.
 - b. Sponsor has the right, in its sole discretion, to maintain the integrity of the Contest, to void entries for any reason, including but not limited to: (i) multiple accounts from the same user from different email addresses; (ii) the use of bots, macros or scripts, or other technical means for entering/sharing; or (iii) Entrant's use of untruthful, false or fraudulent information.
 - c. Any attempt by an Entrant to deliberately damage the VRV App or undermine the legitimate operation of the Contest may be a violation of criminal and civil laws and should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
- 9. Representations and Warranties:** Entrants represent and warrant that they are eligible to enter this Contest, and that all information provided to Sponsor is true, complete and correct. Sponsor makes no warranty, representation or guarantee, express or implied, in fact or in law, relative to the use of any prize, including, without limitation, quality, merchantability, or fitness for a particular purpose (unless Sponsor provides the Contest Winner with written warranties). Further, no responsibilities are accepted for any additional expenses, omissions, delays, or acts of any government or authority. Void Where Prohibited.
- 10. Limitation of Liability:** Entrants agree to release and hold harmless Sponsor and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) such entrant's participation in the Contest and/or his/her acceptance, possession, use or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to, the malfunctioning of any computer, cable, network, hardware, or software; (iii) the unavailability or inaccessibility of any transmissions or telephone or Internet service; (iv) unauthorized human intervention in any part of the Contest; (v) electronic or human error which may occur in the administration of the Contest or the processing of winners.
- 11. Indemnifications:** Entrants agree to indemnify, defend, and hold Sponsor and its affiliated entities and their respective officers, directors, members, managers, employees, contractors, attorneys, assigns, representatives and agents harmless from and against any damage, cost, loss, liability and expense (including, without limitation, attorneys' and experts' fees and costs)

incurred in connection with any third-party claim (whether judicial or non-judicial), demand, or action (each, a “Claim”) alleging facts or circumstances that, if true, would constitute: (i) a breach of any representation, warranty, or other obligation contained in these Contest Rules by Entrant, (ii) the negligence or willful misconduct of Entrants as any part of their participation in this Contest.

12. Right of Publicity:

- a. Except where prohibited, Entrants in the Contest and acceptance of Prize constitutes each winner's permission for Sponsor and Sponsor’s affiliates to use his/her name, address (city and state only), likeness, photograph, picture, portrait, voice, biographical information, and/or any statements made by each Contest Winner regarding the Contest, or Sponsor for advertising or promotional purposes without notice or additional compensation.
- b. Entrants further agree that their names may be displayed by Sponsor on a list of the one thousand (1000) Entrants to complete the applicable Contest the fastest.

- 13. Disputes:** THIS CONTEST IS GOVERNED BY THE LAWS OF THE STATE OF CALIFORNIA, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in this Contest, participant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Contest, shall be resolved individually, without resort to any form of class action, exclusively before a court located in San Jose, California. Further, in any such dispute, under no circumstances will participant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental, or consequential damages, including reasonable attorneys’ fees, and participant further waives all rights to have damages multiplied or increased.
